BACKGROUND INFORMATION "FLOODS – 2014" Situation analysis

Description of the disaster

The heavy rainfall in Eastern Croatia from 13-15 May 2014 has caused large-scale flooding with a subsequent collapse of transit routes and evacuation of the local population. In three days the precipitation levels have exceeded the average for three months. The historic water levels flooded homes forcing approximately 15,000 people to evacuate their homes to safe areas, and taking two lives. About 36,000 people in Croatia are currently endangered by the floods. Over 17,000 school children are currently unable to attend school. More than 100,000 homes, 230 schools, businesses, roads and railways were washed out by the flooding in the region; subsequently Croatia has also taken in temporarily displaced citizens from neighbouring Bosnia and Herzegovina.

The affected municipalities in Croatia include: Gunja, Drenovci, Đurići, Račinovci, Rajevo Selo, Strošinci, Soljani, Posavski, Podgajci, Bošnjaci, Županja, Štitar, Babina Greda, Vrbanja. The following numbers of residents have been affected by the floods from these towns:

- Gunja (5,033 residents)
- Rajevo selo (1,407 residents)
- Strošinci (696 residents)
- Račinovci (982 residents)
- Drenovci (3,049 residents)
- Đurići (418 residents)
- Pos. Podgajci (1,568 residents)
- Bošnjaci (4,653 residents)
- Županja (13,775 residents)
- Štitar (4,262 residents)
- Babina Greda (2,608 residents)

The most effected cities and municipalities are: Slavonski Brod, Municipality of Oriovac, Municipality of Slavonski Šamac, Municipality of Oprisavci, Municipality of Okučani and the wider area of Županja. The integrity of the landfills surrounding Županja, Topola, Bošnjaci and Gunja are still threatened.

Current situation

On 20 May, on the proposal of the director of the National Protection and Rescue Directorate, the Croatian Government declared a state of emergency for the area of Vukovar-Srijem County, which was hit by floods along with four other Counties.

The National Protection and Rescue Directorate has been appointed as the national coordinator of immediate relief and assistance coordinating inter-ministerial and agency task force. All governmental bodies have contributed assistance within their sector-specific issues.

It is estimated that over 4,000 officials and an even larger number of volunteers have been activated directly in activities related to rescue and protection.

The Croatian Government has approved a programme of communal public works in order to contribute to the rehabilitation from the consequences of flooding.

In a coordinated effort, the Ministry of Social Policy and Youth, with the Ministry of the Interior and Ministry of Defence collected humanitarian aid from citizens and have already sent over 250 truckloads of assistance as well as monetary and psychosocial assistance to evacuated families.

As of 22 May, the water level is stagnant or has started to recede. All available forces for protection and rescue activities continue to work on strengthening the existing and in building new dikes, sharing food and water for vulnerable populations, rescuing survivors and disposing of animal carcasses. The situation remains complex due to landslides and road damages. State and local authorities are engaged in on-going evacuation efforts.

An analysis of the current situation in affected areas has begun, including a breakdown of necessary of activities and tasks for the forthcoming period was performed. The most complex situation is still in the Vukovar-Srijem County.

Even though water levels have begun to recede there is a fear of new disasters since the area is contaminated with landmines and other exploded remnants of war. Due to the flooding the landmines may have been dislocated outside the previously marked locations, which make the subsequent clearing and the reconstruction of the flooded areas even more delicate and dangerous. The cleaning of landmines in two municipalities of Gunja and Vrbanja is estimated at the cost of 4 million euros. Together with experts from Bosnia and Serbia, Croatia will establish a Joint Commission to find a regional solution for this sensitive issue.

In general, at this moment we have the capacities to address the immediate humanitarian relief needs in Croatia for food, shelter and medical care, as well as provide assistance to the neighbouring countries. However, we anticipate that in the medium- and long-term there will be a gap between the immediate relief and subsequent rehabilitation, reconstruction and development.

Needs analysis:

Detailed assessment reports are still being prepared. However, most of the affected municipalities and the initial analysis highlight the following key priorities for the flooded areas.

Immediate short-term needs:

- Food and non-food items;
- Safe drinking water and hygiene items;
- Blankets, Linen sheets, Mattresses;
- Rubber boots;
- Plastic utensils and plates;
- Water disinfectants;



- **•** Hygiene parcels;
- Baby and adult diapers;
- Cloths for new-borns and children;
- Water pumps;
- Generators;
- Candles and flashlights;
- Insect repellents.

Medium term needs:

- Financial support for demining;
- Emergency shelter and mobile housing;
- Support for demolition and clearing
- Support for re-building damaged houses;
- Cleaning supplies;
- Disinfectants;
- Masks and gloves;
- Spray pumps for disinfectants;
- Construction supplies;
- Food and non-food items;
- Safe drinking water and hygiene items;
- Big water pumps, Small water pumps;
- Generators;
- Heaters for drying walls dehumidification;
- Hydro-meteorological equipment;
- Incinerators for dead livestock and debris.

Long term needs:

- Financial support for possible long-term care and accommodation;
- Financial support for reconstruction of damaged railways, roads, water mains, sewage, schools, day cares, health clinics etc.;
- Building materials;
- Furniture;
- Appliances;
- Other materials and supplies necessary for the return of residents to their homes.
